

Koala habitat restoration project: Landholder Expression of Interest

The Bega Regional Circularity Cooperative is partnering with the NSW Koala Strategy to restore a minimum 60 Ha of koala habitat on private land within or adjoining the Murrah Area of Regional Koala Significance "ARKS" (see Map 1). We are seeking expressions of interest from private property owners in the eligible area who are interested in undertaking on ground works to restore koala habitat.

The maximum funding available for works is \$2000/ha and, where possible, funds will be paid directly to contractors. All projects must be completed and paid by the 30th June 2025.

Approved activities include:

- Site preparation
- Bush regeneration / weed control
- Stock exclusion Fencing

- Seed/tubestock purchase
- Tree planting

Selection criteria:

- 1. Project site located on private land within the Bega ARKS boundary (Map 1)
- 2. Proposed project can be implemented and completed successfully within the \$2000/ha budget.
- 3. Project involves the implementation of an approved restoration activity.

Priority will be directed to projects that restore the habitat of existing koala habitat and to projects that provide the greatest value for money.

Project Requirements

Restoration works are to be undertaken in accordance with the Koala Habitat Restoration Guidelines (DPE 2022). This includes that:

Plantings must include at least 30% of total canopy trees that are koala preferred tree species (i.e. primary or secondary preferred food trees) for the region and should also include non-eucalypt trees and shrubs for shelter.

Plantings must adhere to planting density guidelines for the relevant region (refer to the online koala management area (KMA) revegetation fact sheets).

Restoration activities undertaken at sites with existing koala habitat (eg fencing, weed control) must have at least 30% of total canopy trees that are koala preferred tree species.

Restoration monitoring will need to be undertaken to measure the success of weed control and the survival of seedlings.

All restoration projects must be registered in the Habitat Restoration HUB.
